#### **Course Description and Objectives**

This MBA-level online course presents a comprehensive overview of the integral roles played by accounting and finance in contemporary business environments. The initial segment of the course places a spotlight on accounting as the language of business, delving into fundamental assumptions and principles, understanding the content and purpose of financial statements, and exploring the practical uses and limitations of financial statements. The latter part of the course shifts focus to the crucial role of finance in supporting various functional areas within a business. Participants will engage with topics such as the time value of money, risk assessment, and the intricacies of capital structure. Learning will be facilitated through a variety of mediums, including study team collaborations, case studies, simulations, relevant articles, and active participation in discussion boards. Emphasizing an interactive learning experience, the course is also enriched with an extensive online component. Assignments and participation, designed to reinforce practical application, carry substantial weight in the evaluation process. This course aims to empower students with the essential skills and insights required to navigate the complex intersection of accounting and finance in the dynamic business landscape. - Describe the underlying principles, relationships, content, and purpose of each of the financial statements (1,3,4,5)
- Explain orally and in writing the role of basic principles of accounting and finance in the business world. (1,3,5)
- Describe compounding, discounting and opportunity cost, risk and sensitivity analysis on variables that affect an investment's value. (1,5)
- Identify and evaluate an entity's capital structure (1,4,5)
