Course Description

This course examines principles, methods and procedures for planning, organizing, leading and controlling people within organizations. Topics include the history of management theory and thought, organizational culture and design, decision-making, managerial communication, and strategic management. More generally this course is an introduction into the field of Management that will hopefully help you think like a manager. You'll learn about the environment managers operate in, different management functions and some of the tools managers use. By understanding why and how managers do what they do you will be better equipped to be successful in an organization as well as decide whether you are interested in a career in Management.

Participation

Class attendance is expected and your participation grade is based in part on your attendance. However, attendance alone is not enough for full participation points. Active participation is encouraged and expected – that means you should ask and answer questions and try to facilitate discussion with other class members. In addition, you are expected to be prepared to share a news items related to class content each class session (see next section).

Scoop.it! Contribution

I love Scoop.it! (you can find it here http://www.scoop.it/)

It has a lot of potential applications but I use it to keep track of things (news items, reports, videos, etc.) I want to share with the class. I expect you to sign-up for a free account, create a "topic" for the class and to find and post at least one thing each week on your Scoop.it! topic along with a couple of sentences explaining how it relates to what we talked about in class. Each class session I will ask for volunteers and/or randomly call on someone to share what they found on Scoop.it! At the end of the semester I will be able to see what you have collected for the entire semester. Your Scoop.it! grade is based both on when and what you share something in class and your collection for the entire semester. We'll talk more about how to get started in class but in general you will sign-up and create a topic for this class, follow my topic for the class and I will follow yours. Hint: this is also a nice way to help you review for exams.

Exercises/Competitions/Quizzes

Reading course material before class is encouraged and expected – as is being able to apply what is covered in class. In order to help keep you motivated, to let me know if you understand the material, and to prepare you for exams there will be periodic exercises, group competitions and quizzes.

Debates

There will be three debates (dates are in the course schedule) but you will each only be part of one debate (60 students is too unruly so we will divide it into three debates with 20 students). There will be a question for each debate and students are responsible for generating 2-3 points for one side and 2-3 points for the other side. The points can be in bullet-point form but must make a clear argument (that means it will take several sentences per point), be typed and are due on the day of the debate. **Students must also cite and document at least one academic source for each argument point (so a total of 4-6 different academic sources).** The debate questions are:

Debate 1: Group work in college is a good idea.

Debate 2: Ethics should be taught in college.

Debate 3: American CEOs are paid too much.

On the day of the debates, students will be randomly assigned to one of three groups: "Pro" position, "Con" position, or Judge. Debates will be conducted in the following manner:

 Groups will have 15 minutes to develop a consistent, logical argument for their assigned position

- Team A will present opening argument to judges -- 5 minutes MAX
- Team B will present opening argument to judges 5 minutes MAX
- Groups will reconvene and have 10 minutes to develop rebuttals
- Groups present 3 minute rebuttal
- Judges have 10 minutes to determine debate winner and indicate why

Exams

Exams are a mix of short answer and essay (sorry, no Scantrons). We will review what is expected and the format in detail prior to each exam but here is a good general way to prepare for them - we will not cover everything in the chapters and I will also include things outside of the textbook so just reading the textbook will not prepare you for exams. The best way to review for exams is to start with my slides from each class and your notes and then go to the textbook to fill in gaps where you don't understand what we talked about in class. You will do a lot of writing so be prepared.

Equipment
